a) Composite Scheme of Arrangement between Greenply Industries Limited (Demerged Company) and Greenpanel Industries Limited (Resulting Company) and their respective shareholders and creditors.

b) Appointed Date: April 01, 2018

c) Effective date: July 01, 2019

d) Date of Allotment: July 19, 2019

e) In terms of the Scheme and pursuant to Sections 230 to 232 and other applicable provision of the Companies Act 2013 and Income-tax Act, 1961, the Demerged Company along with all its assets, liabilities, contracts, arrangements, employees, Permits, licences, records, approvals, etc., without any further act, instrument or deed, be transferred to and be vested in or be deemed to have been vested in the Resulting Company as a going concern.

In consideration of the above demerger, including the transfer and vesting of the Demerged Company into the Resulting Company, the Resulting Company shall for every 1 (one) fully paid-up equity share of Re. 1 (Rupee One) each of the Demerged Company, issued and allotted to each member of the Demerged Company 1 (one) fully paid-up equity share of Re. 1 (Rupee One) each, of the Resulting Company.
